**Operating notes:**

- Supervision ratio is 1 instructor to 30 participants. There is no requirement for an additional adult.
- Activity leader to be trained to in-house syllabus for the activity. Refresher training as directed by coaching sessions.
- No special requirements for Chief instructor. Technical advice from the Group Activities Manager.
- Equipment and materials provided are selected to be appropriate for safe use by children.
- Water-based substances are purchased in preference to solvent-based products.
- Activity area must be suitable for the purpose and size of the group, (chairs, tables, floor surfaces and table surfaces).

**Risk – Benefit Statement:** There is a low risk of allergies to chemicals and products being used, but high levels of creativity and participation, making the risk tolerable.

Equipment use – Items such as scissors, sharp pencils, styluses, clay modeling tools, etc. causing cuts	Participants	<ul style="list-style-type: none"> <li>• Keep all participants under close supervision at all times.</li> <li>• Tell participants to take care when using sharp craft equipment and lend assistance to those who need help.</li> </ul>	Very Low
Allergic reactions or upset stomachs – Caused by ingestion of or exposure to paints, glue vapours, face paints and natural items collected outside	Participants, Instructors	<ul style="list-style-type: none"> <li>• Check medical forms for allergy information before the activity. Anyone with an allergy to e.g. face paints must not be brought into contact with these substances.</li> <li>• Issue rules or provide supervision when collected natural items (e.g. berries, fungi).</li> <li>• Ensure everyone washes their hands at the end of the activity and before eating food.</li> </ul>	Very Low
Mask Making – Damage to hair, skin, eyebrows, etc. from plaster/Modroc, and suffocation risks	Participants	<ul style="list-style-type: none"> <li>• Ensure petroleum jelly/Vaseline is smeared over all the skin, eyebrows and other exposed areas that will be covered by the plaster bandages.</li> <li>• Make sure that nostrils or mouths are not covered – participants must be able to breathe.</li> </ul>	Low
Swinging back on chairs – Risk of falling backwards causing banged heads and bruises	Participants	<ul style="list-style-type: none"> <li>• Chairs with wheels rather than legs are preferred to discourage tipping.</li> <li>• Tell participants that they are not to swing back on their chairs. Be vigilant for those who break the rule.</li> </ul>	Very Low
Apparatus and Equipment – Furniture, apparatus and other equipment in shared spaces.	Participants	<ul style="list-style-type: none"> <li>• Remove or re-arrange any furniture or apparatus in the area so that it meets the needs of the activity and the group.</li> <li>• Ensure ‘launch areas’ or ‘drop zones’ are clear of people before using them for testing constructions.</li> </ul>	Very Low
